### CALL TO ORDER

The February 18, 2016, regular meeting of the Destination Newport Committee was called to order at approximately 2:03 P.M. ### CONSENT CALENDAR

The consent calendar consisted of the following items:

MOTION was made by Clark, seconded by Rabourn, to approve the consent calendar, as presented. The motion carried unanimously in a voice vote.

#### MEDIA CONSIDERATIONS

Reviewed the proposal for Bend Magazine. Committee decided to table this item until committee see new budget after supplemental budget is in effect.

### <u>OTHER</u>

The committee reviewed a Tourism Marketing Grant for Newport Parks and Recreation Department for the Coast Classic Mountain Bike Race. This would be the third and final year for a grant for this event.

The committee reviewed a Tourism Marketing Grant for Oregon Coast Aquarium for the Oregon Coast Aquarium 5K formerly Flippers, Feathers, and Fins 5K. This would be the second year for a grant for this event.

Committee reviewed and edited a letter to the City Manager requesting additional funding for the 2016-17 Fiscal Year.

Reviewed Lincoln County Fair Report on their Tourism Marketing Grant. Reviewed MOTA Center Proposal for an outdoor advertising. Proposal was \$17,000 a month which is greatly reduced. It is available come June 1<sup>st</sup>. Sign is not lighted.

Davis shared a letter sent to ODOT by the Chamber regarding issues with the planned closure of Highway 20. With the current planned closure, the City could see 35% to 40% loss in revenues. The Committee discussed the need for some creative marketing in the

event the closure schedule does not change. There is a meeting with County and City stakeholders Friday, February 19 with ODOT.

### **DISCUSSION AND ACTION**
