Night inspections have found no new issues to be reported.


FAA has had no issues with 16 PAPI. 34 PAPI still OTS per FAA.


Received updated Airport Certification Manual from FAA. Working on finishing updating rest of ACM appendixes.


Stripping has been finished on runway 2-20 and taxiway echo and delta. It looks realy nice.





SUBJECT: Regarding the June 9 Airport Committee Meeting

#### Discussion on Proceeding with a Request for Proposal for the Operation of the Airport

At the April meeting of the Airport Committee, the Airport Committee requested a report on the key elements that could be included in a request for proposals for the operation of the Newport Municipal Airport. Please note that I will be providing to you (hopefully by the end of the day on Monday) an outline of key provisions that could be included in a request for proposals for the airport operations. I think it will be important for the Airport Committee to have a clear understanding of the scope of the contractual operation of the airport if the committee recommends to the City Council that we proceed along these lines. I have been compiling information on this matter and will provide an outline of the key elements that could be part of the RFP for Tuesday discussion. As an alternative, the Airport Committee could recommend that the City Council seek proposals for the traditional Fixed Base Operations at the airport or could recommend that we proceed with an hiring an Airport Manager instead of contracting the operation of the airport.

#### Airport Hanger Leases

I have requested a compilation of the status on the various leases at the airport from city staff to understand where the city is at with hanger leases.

Currently the city has 20 box hanger leases. The box hangers are privately owned and exist on airport property. Please note that 13 of the leases have been renewed with the new box hanger lease that was reviewed and recommended by the airport committee some time ago. In compiling our review it appears that there are seven leasees that have not executed the new agreement. It is our intent to send a notice to these seven box hanger owners requesting that they execute the new standard lease since their leases have expired and have not been renewed.

We would like to get this cleaned up during the next few weeks. We have also conducted review of the current T hanger leases. The T hangers are city owned and leased to the various tenants. Please note that seven of the ten T hangers have current leases while three of the original leases remain with expired leases. In addition, for three of the T hangers tenants have swapped T hangers without executing new leases. We will need to have current leases executed in these situations. We also need to make it clear that anytime anyone wishes to change hangers both parties will need to execute new leases with the city.

I look forward to seeing you on Tuesday. Please let Bob know if you will be unable to attend.

Night inspections has no new issues to report.






We are official on the wings points program. I have to call to have the software installed on our point of sales machine.




