Other Meeting Protocols

- Attend all meetings and prepare for meetings by reading materials in advance and arriving on time.
- Support the facilitator in ending meetings on time. If agenda items cannot be completed on time, the group will decide if the meeting should be extended or if the item can be rescheduled to another meeting.
- Notify staff if we have an unavoidable conflict that requires us to be late or absent. Staff will provide advance notice of meetings and will make every effort to provide meeting materials the group needs for making recommendations in advance of meetings.
- The facilitator may check the pulse of the group through informal quick polls, which can be indicated by the group with thumbs: up for agreement, down for disagreement.
