

EXHIBIT A

Adjusted Book 281 Page 560

A tract of land located in the Southeast One-Quarter of Section 32, Township 10 South, Range 11 West, Willamette Meridian, City of Newport, Lincoln County, Oregon and being more particularly described as follows:

Beginning at a 5/8 inch iron rod on the westerly boundary of the tract per Book 312 Page 1395 at the southwest corner of said tract's frontage along the easterly right-of-way line of NW Oceanview Drive (45.00 feet from centerline) which bears North 07°22'40" East 1108.25 feet from a 5/8 inch iron rod with a yellow plastic cap inscribed "FAIL LS 357" at the southeast corner of Lot 2, Block 2 of the plat "Newport Beach Estates"; thence along said easterly right-of-way line North 08°08'04" West 50.00 feet to a point; thence continuing along said easterly right-of-way line South 81°51'56" West 15.00 feet to a point; thence continuing along said easterly right-of-way line North 08°08'04" West 11.40 feet to the True Point of Beginning; thence continuing along said easterly right-of-way line North 08°08'04" West 50.59 feet to a point on the northerly line of the tract per Book 281 Page 560; thence along said northerly line North 82°06'56" East 50.00 feet to the northeast corner thereof; thence along the east line of said tract South 08°08'04" East 3.65 feet to a point on the north line of said Book 312 Page 1395 South 87°26'23" East 38.19 feet to a point; thence leaving said north line South 00°00'00" East 51.62 feet to a point; thence North 90°00'00" West 81.04 feet to the True Point of Beginning.

The above described tract of land contains 4,502 square feet, more or less. The Basis of Bearings is Oregon State Plane, North Zone, NAD83.
