SUBJECT: Status Report for the Three-Week Period Ending Friday, May 14, 2021

Over this period of time, it has been good to try to catch up on a number of backlogged items due to the budget process. With the proposed budget out, efforts have shifted to responding to the questions and potential changes that were requested by individual Budget Committee members during the initial budget work session. The Budget Committee will be reconciling the budget at the Tuesday, May 18 meeting, approving a budget at the May 25 meeting and submitting the budget to city Council for adoption. I appreciate everyone's role in developing this financial plan for the next fiscal year.

### <u>Highlights of activities over the last three weeks include the following:</u>

- Participated in the Oregon Coast Aquarium Board meeting. Things are beginning to look a bit more normal around the aquarium as standards have been relaxed regarding visitation to these types of attractions. The new admissions annex is up and running. This is located to the left as you approach the aquarium facility, and allows tickets and other activities to occur outside the lobby area. The capital plan continues to make significant progress, with a recent \$5 million gift being made to the aquarium from private sources to help realize the capital plan. The aquarium is also working with legislature to restore the \$5 million appropriation that was part of the same lottery bond funding that the City was slated to receive for the Big Creek Dam. The aquarium has received over \$16 million in commitments to date. Through generous operating donations, and significantly reducing operations and expenses, the aquarium has been able to muscle, and has experienced a good spring with sufficient revenues coming in during the last couple of months to offset their operational expenses. Overall, through good management, the aquarium has done remarkably well in weathering the COVID-19 pandemic.
- Councilors Parker and Jacobi, Derrick Tokos, Chris Janigo, and I, met with PUD to
  discuss the street lighting program that would be coordinated by a third party such
  as Ameresco. PUD has concerns regarding the payback that would be necessary
  to support this type of project, and would like to gain a better understanding of how
  replacement of light fixtures with dark sky fixtures would work from a lighting

standpoint, if existing pole locations are utilized. Furthermore, the PUD is hesitant to establish separate rate structures for Newport from what is used throughout the region served by PUD, to carve out this type of work in one of the cities they serve. I will be setting up a meeting internally with Ameresco to discuss pathways forward on this matter prior to meeting with the PUD to continue this discussion.

- Lance Vanderbeck, Derrick Tokos, David Allen, and I, met to discuss the letter of
  intent to lease 10.8 acres of airport property outside the fence for future
  development. This proposal was presented to the Airport Committee and
  presented to the City Council, with both bodies authorizing us to proceed with the
  development of a lease agreement with McWatkins, LLC, (Mark Watson,
  Principal). We will be bringing back an agreement for Council review in June.
- Held a bi-monthly meeting with Peggy Hawker to review various issues that she is working on.
- Had a meeting with PUD regarding use of the conduit the City owns under Yaquina Bay. Over the years, there were a number of verbal arrangements made between the City and the PUD regarding use of fiber optic cables throughout the city. At the time the under-bay crossing was done for the new wastewater treatment plant, the City also installed a series of conduits under the bay. PUD would like to utilize one of the conduits to remove their fiber optic crossing from the Yaquina Bay bridge. We have spent a significant amount of time sorting out the history of the relationship between the PUD and the City regarding shared fiber optic use. We will follow up administratively on this issue to reconstruct some of the past understandings.
- Participated in a meeting in Portland, Oregon, the morning of Tuesday, April 27. ICMA Executive Director and representatives from ICMA were in Portland to determine whether the 2021 October ICMA Annual Conference will be an in-person event. ICMA has held the annual conference one other time in Portland in 1999. ICMA has indicated that they are planning to move forward with the conference in October. There is still some wiggle room in this commitment. A final call will be made in June.
- Met with Wayne Belmont from Lincoln County, Brett Fox, David Allen, and Derrick Tokos to discuss the 2<sup>nd</sup> Street vacation. The substance of this meeting was conveyed to the City Council as part of the report and recommendation that Council acted on at the May 3 Council meeting.
- Met with David Allen, Mike Murzynsky, and Linda Wertman to continue efforts to refine the purchasing policy that we would like to put in place beginning of the new fiscal year. This policy will include a number of changes that were outlined in the Finance Work Group requirement for purchase orders for purchases in excess of \$5,000. We are meeting on a bi-monthly basis to work our way through the development of this policy.
- Along with members of the City Council, Peggy Hawker, Mike Murzynsky, Steve Baugher, and I, participated in the first Budget Committee meeting. On Tuesday, April 27. We managed to get through the entire review of the budget with 85 hit and wish list items that required responses for the second budget meeting being held Tuesday, May 18.
- Met with Bill Barton who is interested in trying to find a way to help address homelessness issues in the City of Newport. At this point, Mr. Barton is trying to

understand the extent of the problem, and what is being done locally to address these issues. I shared the report with him from the Homelessness Task Force, and told him where we stand with the recommendation. He has since met with Grace Wins Haven, and has arranged to do a ride-a-long with Jovita, one of our Community Services Officers, and is meeting with others to determine how he may be able to help. I appreciate his interest in this matter.

- Jason Malloy and I met with homeowners on Pacific Street regarding the issues they have on their property of homeless individuals establishing camps on their property. Their home is on a bluff above the beach. Several weeks ago, during one of the dry, windy spells, a camp set fire to the surrounding brush and trees below their home. While they have been tolerant of this activity, this was something that was of great concern to them. We reviewed the areas where the camps had occurred (and where the fire occurred). They understand that there is not much we can do to secure the beach side of their property. Chief Malloy suggests that they consider installing game cameras, and if people are illegally trespassing on their property, to call the police. They are going to explore this option. Jason emphasized that they need to feel free to call the police when people are trespassing on their property.
- Met with several employees from public works regarding an incident that occurred among the three employees of this department. A subsequent meeting was set up between two employees who have had some differences with each other to try to resolve this matter. The incident will be reviewed and investigated separately from this process.
- Held a bi-monthly meeting with Laura to discuss various issues at the library.
- Met with Chris Janigo, Peggy Hawker, Mike Cavanaugh, and Jim Guenther to prepare for a deposition regarding an individual who slipped and fell on the Ocean to Bay Trail in 2019.
- I was Peggy Hawker's guest on "Newport Today" to discuss the report of the Finance Work Group on Thursday, April 29.
- Participated in a DNC meeting to discuss the transient room tax increase and to discuss possible reorganization of the way DNC functions. I have asked the Committee to consider a different structure that could include the City contracting with the Chamber, or other organization, to provide DNC marketing for Newport. Any changes in the structure would come through a recommendation from the Committee to the City Council. If changes are recommended by the Committee, a work session would be set up to discuss how those changes might be implemented.
- Followed up with the ICMA regarding the visit to Portland.
- I participated in an OCCMA Conference Host Committee meeting to reinitiate our planning efforts for the conference.
- Participated in a lengthy deposition, deposed on behalf of the City of Newport, and personally, as well, regarding the slip and fall occurring on the Ocean to Bay Trail.
   The deposition lasted for almost three hours. They also deposed Jim Guenther for additional testimony.
- Met with the bureau group manager for HDR regarding HDR's support for the Big Creek Dam. The new manager wanted to establish a direct relationship with the

City regarding the dam project. During our discussion, I indicated that we may utilize a different company to evaluate the existing earthen dam to address the issues outlined by the State dam engineer regarding leaks in the spillway. He indicated he was comfortable with the City moving in that direction. I told him we have been happy with the work that they have done on the replacement dam project, and that the City anticipates continuing to work with them. Once we have a new City engineer in place, we will follow up with him to continue moving this process forward.

- Conducted follow-up interviews with two of the candidates for City engineer. I hope to have this process completed within the next couple of weeks.
- Prepared agenda items for the May 3 City Council meeting.
- Held a routine Department Head meeting.
- Met with Paul Schuytema of the Lincoln County Economic Development Alliance regarding renewal of the City's enterprise zones. This is something that is administered by the County. Existing zones are expiring, and enterprise zones provide tax abatement opportunities for manufacturing developments that occur in the City. We plan to have a recommendation for the Council's consideration at the June 7 Council meeting.
- Participated in a joint work session with City Council and the Planning Commission to discuss the transportation plan. This was followed by an executive session to discuss elective bargaining positions relating to the negotiations with the Newport Police Association.
- Participated in the regular May 3 Council meeting.
- I was on vacation on Tuesday, May 4, through Thursday, May 6, to get work done around the house. (With budget time, there has been a lot of things neglected at home!)
- Held bi-monthly meetings with Richard Dutton to discuss IT issues, and Mike Cavanaugh to discuss Parks and Recreation issues.
- Provided testimony supporting a request for \$14 million for the Big Creek Dam Project to the Subcommittee on Capital Construction. The Committee included the Senate Majority Leader, Speaker of the House, and other key senators, and representatives, who were hearing testimony on Senate Bill 5534. I appreciate the efforts of Representative Gomberg to increase the State's participation from the original \$4 million to potentially \$14 million. It seems that the legislators are all very familiar with this project. We will see how the funding shakes out moving forward. The original \$4 million was intended to assist with design and permitting. The \$10 million would be to complete that process plus funds to utilize for building the access roads and other preliminary work necessary to prepare for building a new dam.
- Met with David Allen, Derrick Tokos, Chris Janigo, and Clare Paul, to prepare for the next meeting with PUD on the franchise development.
- Participated in the tail end of the Short-term Rental Work Group meeting. (this
  overlapped with the Big Creek Dam testimony). A discussion was held regarding
  comments that could be construed to be attacking individuals (whether citizens
  with complaints about short-term rentals, or short-term rental owners concerned

- about citizens complaining about them). Hopefully, that discussion helped clear the air over those concerns.
- Met with new OCCA Executive Director, Jason Holland, to discuss the relationship between the City and OCCA. I believe that Jason is well-positioned to continue moving OCCA in a positive direction. I think he is also well-suited to reinitiate their capital campaign and oversee on behalf of OCCA the relationship between OCCA and the City that will be necessary to complete the public improvements to the PAC with funds raised for that purpose. He has spent some time catching up with City business, including becoming familiar with the City's 2040 Vision. He is also very complimentary regarding the statement on diversity, equity, and inclusion that the Council has previously passed. Based on my initial meeting, I feel confident that Jason is going to do a great job for both OCCA and the City
- Met with Chris Janigo, David Allen, Brian Gardner, and Jason Holland regarding the agreement to proceed with architectural services for the PAC. The funding for these services will be provided to the City by OCCA from funds raised to date. A new agreement was reviewed for this project by Council at the May 17 Council meeting. The amount of funds raised in this revised agreement is less than what was originally committed to by OCCA, when the City first made the pledge for \$600,000 of assistance. It will be important for Council to confirm they are willing to continue with this commitment, which would be on a smaller scale than what was initially expected. My recommendation is that Council move forward with the agreement.
- David Allen, Derrick Tokos, Chris Janigo, Clare Paul, and I, met with PUD representatives to negotiate a new franchise agreement between the City and the PUD. PUD has several concerns over some of the elements that we want to include in a new franchise agreement. We reviewed this with the City Council at the May 17 work session.
- Barb James, Jason Malloy, David Allen, and I, participated in a conference call with Mark Wolf to prepare for our next negotiations session with the Newport Police Association.
- Held individual bi-monthly meetings with Jason Malloy, Rob Murphy, and Lance Vanderbeck to discuss individual department issues.
- David Allen, Barb James, Rob Murphy, and I, met to discuss the status of negotiations with the IAFF. These negotiations have basically been stalled, with IAFF opting not to schedule future meetings since the last meeting scheduled in November. I am proposing that we settle the current fiscal year with a one-year agreement that would provide a 2% cost of living adjustment, and continue negotiations on a contract that would be put into place for a three-year period beginning July 1, 2021. This would allow us to close out issues relating to the current fiscal year, and move forward with a contract for the next three years.
- Held a bi-monthly meeting with Laura to discuss library issues.
- Met with Mike Cavanaugh and David Allen to clean up the contractual relationship we have with Coimagine Health for a program with the 60+ Activity Center. This is a program that has been provided with direct funding from the Friends of the 60+ Center with health records of participants being kept by the City. We need to clean up this process. It is our intent to move forward with a memorandum of understanding and an agreement with the Friends, as well as the provider of these

- services who were hired by the Friends directly, to address the HIPPA concerns we have relating to the medical records kept as part of this program. In the future, we are going to recommend that this position be hired as a part-time staff position which will give us the adequate legal control we need to maintain safe keeping of the records that fall under HIPPA.
- Mayor Sawyer, Chris Janigo, and I, participated in a meeting with our lobbyist, Jenny Dresler, and Senator Anderson regarding Big Creek Dam. Senator Anderson wanted to have a few more specifics of how the additional \$10 million would be used by the City for this project. We indicated it would be used to complete design, permitting, and to begin building the auxiliary items such as access roads (which is critical even for the current operations to respond to any type of dam failure since the existing road would likely be unusable if the dam begins to fail). He seemed satisfied with this answer, and indicated that we have done our homework, since literally everyone in the legislature seems to be aware of Big Creek Dam.
- Prepared agenda items for the May 17 City Council meeting.
- Participated in a conference call of the OCCMA Host Committee co-chairs to figure out the next steps based on ICMA's intent to move forward with the conference in Portland.
- Held a bi-monthly meeting with Mike Murzynsky.
- Met with Chris Janigo, Clare Paul, and Steve Stewart to discuss the process to move forward with the upper dam work. The State is requiring us to evaluate the leaks and voids existing around the spillway. This issue was discussed initially with HDR, as well as Jacobs Engineering in Corvallis (formally C2HM Hill), who has extensive experience with earthen dams in Oregon. Jacobs Engineering designed the original dam, plus heightened the dam, as well. In evaluating the proposals, it is our conclusion that we should work with Jacobs Engineering with the evaluation of the dam, due to their direct involvement of the construction, and the extension of the dam, as well as their experience of earthen dams in Oregon. City Council approved this recommendation at the May 17 Council meeting.
- David Allen, Derrick Tokos, Richard Dutton, and I, met to continue piecing the history together of the under-bay crossing which added conduits for fiber optics, in light of the request from the PUD to utilize one of these conduits. In addition, there were a number of "handshake" deals where the City has enjoyed shared use of some of the PUD's fiber optic lines, which were never been documented by any agreements. We have opted to start with determining the value of utilization of the under-bay conduits, then review any offsets applicable, based on previous accommodations by the PUD for use of the under-bay conduit. We will be following up with the PUD after we obtain additional information and understanding of the relationship of the City with the PUD relating to fiber optics.
- Met with Jason Malloy regarding a complaint from residents who are dealing with various issues relating to the homelessness population in Newport. I will be meeting with the couple later this week.

Please note the significant recovery in room tax from March of last year when COVID-19 began shutting things down. This fiscal year, July and August remain below recent collections, with September, October, November, and December, either being the highest or second highest months of room tax collection over the past several years. So far in 2021, January was the highest ever, February was down a bit from 2019-2020, which was the previous highest year ever, and March exceeded the highest March collections by almost \$100,000. If these trends continue through the fiscal year, it is likely that our room tax collections will be at or above the 2018-2019 Fiscal Year. I believe that the coast has benefitted by people taking shorter trips closer to home. This has resulted in a good recovery of room tax revenues following last fiscal year, which was impacted significantly by travel closures due to COVID-19.
- Attached is a summary from Dig Deep Research showing a history of the activities they have conducted and the results the City has realized from their efforts.

Attached is a letter and copy of a \$24,936 check for dividends received by the City from SAIF. This represents a dividend equal to 17.56% of the standard premium paid by the City for worker's comp insurance.

Co-Chairs Girod and Holvey,

My name is Spencer Nebel, and I am the City Manager for the City of Newport. I'm here today to request your consideration of \$14 million for the Big Creek Dams Replacement Project.

First, I want to thank you for authorizing our project for \$4 million in the 2019 session.

Ten years ago, city engineers discovered real threats to our City's sole source of water which is stored behind the Upper and Lower Big Creek Dams. They found that the foundation material that the Big Creek Dams were built on is unstable and could fail in the event of a moderate earthquake.

To make matters more urgent, the State recently discovered advanced seepage issues in the upper dam and downgraded the safety rating to "unsafe" due to the risk of catastrophic failure.

Newport has applied for several state and federal grants, and invested nearly \$6 million of our own money, but we lost our \$4 million lottery bond allocation that was passed by the legislature in 2019 due to the COVID-19 pandemic. Funding continues to be a challenge.

I want to thank Representative David Gomberg for his advocacy for our project and for submitting the request for \$14 million, not only for design and permitting but also for the construction of our replacement dam. The total project cost is estimated between \$70-80 million dollars, which our small city cannot afford on our own. State assistance would go a long way to increase the pace of the dam replacement project and help the City mitigate the imminent safety risk to our community.

We thank Senator Anderson and Representative Gomberg for their interest and support of our project. On behalf of the City of Newport, I respectfully ask for your consideration of our request for \$14 million in lottery bonding in SB 5534. This \$14 million request includes the \$4 million that was previously authorized to allow the City to move forward with dam design and environmental permitting on the timeline directed by the state in order to secure the City's only water supply and reduce the risk to residents who live within the inundation zone.

Thank you for your consideration of our request this afternoon.

Currently, the City of Newport, Oregon has two dams recently rated as unsafe and at risk of spontaneous failure. They are the Upper Big Creek Dam and the Lower Big Creek Dam. Should either of these dams fail, the result could be catastrophic for the local community, and dam engineers have cautioned that loss of life would most definitely happen. There is very little warning when dams fail, and about a dozen homes are within the flood zone. A park where children play sits just below the lower dam. Roads carry people just beyond that. While the loss of life would be devastating, it would be followed by economic devastation due to the loss of water supply.

To address this situation, a roller-compacted concrete dam would be built between the upper and lower reservoirs. This dam would be higher than the existing dams and would hold the volumes currently stored in the lower and upper reservoirs combined. However, the project would take three to four years to construct at a cost of \$68 to \$83 million. This price tag is too large for a community of Newport's size, and the City is looking at all available local, state, and federal funding sources to mitigate the risk to the local community.

Over the years, we have worked alongside our community partners to generate support for this project as we work to identify potential state and federal funding. We recently submitted an appropriations request to our federal delegation, including community letters of support. In this document, we have included those letters of support, addressed to Congressman Kurt Schrader, from community groups, business interests, and economic development groups, and many others as well as a plethora of news articles about the Big Creek Dams.

- Current water supply is not sized to accommodate future demand or growth
- Reservoirs are unable to store sufficient water to avoid critically-low water levels during peak demand times

# Current Situation Seismically Unstable Water Infrastructure

The soils below either dam could liquefy during a seismic event (3.0 or greater on the Richter Scale), causing significant damage to and/or failure of the dams.

As of 2013, two of the top three most-critical, high-hazard dam projects in the State of Oregon according to Oregon's Dam Safety Engineer are the Upper Big Creek Dam and the Lower Big Creek Dam.


