If this agreement is referred to an attorney for collection, enforcement or interpretation, the prevailing party in any action arising therefrom shall be entitled to an award of reasonable attorney's fees and contract shall be governed by the laws of the State of Oregon and any action arising therefrom shall be proper in any court of competent jurisdiction located in Lane County, Oregon.
