



Addendum No. 1 to Goods and Services Contract Between City of Newport and Salem Fire Alarm

THIS ADDENDUM No. 1 is to the Goods and Services Contract between the City of Newport (City) and Salem Fire Alarm (Contractor) for security and fire alarm services.

Recitals:

- 1. City and Contractor entered into an agreement dated October 29, 2021 (Agreement) for an estimated \$20,205 pursuant to a request for proposals for security and fire alarm inspection, testing, monitoring, and maintenance services, attached as Exhibit A to the Agreement.
- 2. City and Contractor desire to proceed with additional services under the Agreement.

Terms of Addendum:

City and Contractor agree to the following additional services under the Agreement:

- A. City and Contractor will proceed with the proposal/scope of work dated August 15, 2022 for an estimated \$16,395, attached as Exhibit 1 to this Addendum.
- B. This Addendum may be executed in counterparts and a signed copy transmitted by facsimile or other electronic means, each of which will be deemed an original, but all of which taken together will constitute one and the same agreement.

Except as expressly set forth herein, all provisions of the Agreement shall continue and remain in full force and effect.
