## DECLARATION OF REAL COVENANT

I the undersigned owner of real property in the City of Newport, County of Lincoln, State of Oregon, described as follows:

for and in consideration of Business License #6855 with Short-Term Rental Endorsement for the operation of a vacation rental as defined in Newport Municipal Code Chapter 4.25/"Short-Term Rental Business License Endorsements" for the residence at 396 NW 5<sup>th</sup> Street (Lot 6, RHODODENDRON PARK Subdivision) granted by the City of Newport, hereby covenant and agree for myself and my heirs, successors, grantees, and assigns, that:

*Lots 6 and 7, Block 3, RHODODENDRON PARK Subdivision, as described herein, may not be sold or otherwise transferred independent of each other. This restriction shall remain in effect for the duration of the operation of the vacation rental or until the shared property lines are adjusted and/or removed such that the residence located at 396 NW 5th Street (Lot 6) meets the minimum vacation rental parking and landscaping requirements of the Newport Municipal Code Chapter 4.25/"Short-Term Rental Business License Endorsements," at which time the City of Newport will release this covenant.*

It is understood and agreed that this covenant runs with the land and shall be binding on all parties and all persons claiming under them.

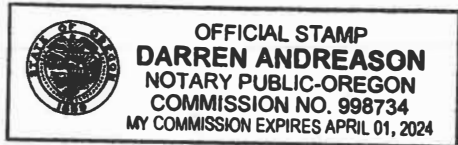
