Amendment No. 2 to Consent Agreement Between City of Newport and Oregon Brewing Company

THIS AMENDMENT NO. 2 is to the Consent Agreement between the City of Newport (City) and Oregon Brewing Company (OBC) dated September 1, 2021.

Recitals:

- 1. City and OBC entered into a Consent Agreement effective September 1, 2021 (Agreement) related to noncompliant discharges from OBC's industrial wastewater pretreatment system.
- 2. Under an amendment to the Agreement dated June 2, 2023, OBC was granted an extension of six months to the 21-month period as set out in Section II.1.b. of the Agreement to complete its technical compliance plan and schedule.
- 3. OBC's technical compliance plan and schedule, as amended dated May 5, 2024, are included and attached to this Amendment.

City and OBC agree to further amend the Agreement, as provided for in Section III.10, as follows, effective on the date of the last signature below:

- A. The 21-month period as set out in Section II.1.b. of the Agreement for OBC to complete its technical compliance plan and schedule, as previously extended by six months, is extended by an additional 12 months to a 39-month period, with an anticipated completion date of December 1, 2024.
- B. This Amendment may be executed in counterparts and a signed copy transmitted by facsimile or other electronic means, each of which will be deemed an original, but all of which taken together will constitute one and the same agreement.

Except as expressly set forth herein, all provisions of the Agreement shall continue and remain in full force and effect.
