## **ORDINANCE NO. 2136**

## AN ORDINANCE RENAMING THE BLACK BOX THEATRE AT THE NEWPORT PERFORMING ARTS CENTER TO THE DAVID OGDEN STIERS THEATRE

## **Findings:**

WHEREAS, Chapter 2.35 of the Newport Municipal Code provides that the Newport City Council may, by resolution, initiate a public hearings process to consider whether or not it is in the public interest to rename a public place; and

WHEREAS, the City Council took such a step on July 16, 2018, with Resolution No. 3815, proposing that the Black Box Theatre at the Newport Performing Arts Center be renamed to honor David Ogden Stiers; and

WHEREAS, the Newport Planning Commission held a duly noticed public hearing on August 13, 2018, at which it considered the factors outlined in Chapter 2.35 for renaming a public place, including whether or not the individual to be honored has made significant contributions to the betterment of the City and its citizens; and

WHEREAS, after providing an opportunity for public testimony, the Planning Commission concluded that David Ogden Stiers contributions to the City of Newport through his celebrated acting career, service as an associate/resident conductor of the Newport Symphony Orchestra, support of the Summer Theatre and Shakespeare camps, support for thespians, and his support for the Oregon Coast Council for the Arts and Performing Arts Center, when taken as a whole, constitute a significant contribution to the betterment of the City and its citizens; and

WHEREAS, the Newport City Council held a public hearing on August 20, 2018 to consider whether or not the name change is in the best interest of the City in light of the Planning Commission's recommendation, public testimony, and other information in the record; and

WHEREAS, after due consideration, the City Council determined that the name change is in the best interest of the City as a whole; and

WHEREAS, notice of the public hearings before the Planning Commission and City Council was provided in the August 10, 2018 and August 17, 2018 editions of the News Times in the manner required under NMC Chapter 2.35.

Based on these findings,

THE CITY OF NEWPORT ORDAINS AS FOLLOWS:

<u>Section 1</u>. The "Black Box Theatre" at the Newport Performing Arts Center, is hereby renamed the "David Ogden Stiers Theatre."

Section 2. This ordinance shall take effect 30 days after passage.
