RESOLUTION NO. 3839

A RESOLUTION NAMING THE BOX OFFICE AT THE NEWPORT PERFORMING ARTS CENTER TO THE CHRIS AND JULIA CARLSON BOX OFFICE

Findings:

WHEREAS, Section 2.35 of the Newport Municipal Code provides that the Newport City Council may, by resolution, initiate a public hearings process to consider whether or not it is in the public interest to rename or name a public place other than a street; and

WHEREAS, the Oregon Coast Council for the Arts requested that the Newport City Council initiate, by resolution, and pursuant to Newport Municipal Code Section 2.35.040, the naming of the Performing Arts Center Box Office to the Julia Carlson or Carlson Family Box Office; and

WHEREAS, following the adoption of Resolution No.3837, initiating the naming of the Box Office, the Carlson Family requested that the Box Office be named the Chris and Julia Carlson Box Office; and

WHEREAS, Julia Carlson was born and raised in the greater Newport area, and began her financial business, Financial Freedom, 19 years ago serving rural Oregon coast communities. Her client base spans four cities in three counties. For years, Julia has provided workshops on personal finance and financial literacy in the three Lincoln County High Schools; and

WHEREAS, Julia's husband, Chris, began his building career working with his father learning the art of fine homebuilding. Chris, an Oregon Certified Master Builder and business owner, employs professional craftsmen who share in the company's commitment to excellence; and

WHEREAS, the Box Office at the Performing Arts Center is the financial center of the building, where reservations are made, seats selected, tickets purchased, and will call is located: and

WHEREAS, based on the Carlson's commitment, dedication, and service to the community, it is fitting that the Performing Arts Center Box Office be named for two successful business owners who both employ and support many people in the greater Newport area; and

WHEREAS, on January 22, 2019, the Newport City Council adopted Resolution No. 3837, initiating the naming of the Box Office at the Newport Performing Arts Center in honor of Julia Carlson and/or the Carlson Family, and subsequent to that adoption, received a request from the family to name the Box Office the Chris and Julia Carlson Box Office; and

WHEREAS, the City Council of the City of Newport directed that staff notice a public hearing for February 4, 2019, at which time, the City Council will accept public comment on the proposed naming of the Performing Arts Center Box Office to the Julia Carlson and/or Carlson Family Box Office; and

WHEREAS, notice of the public hearing before the City Council was provided in the January 30, 2019 edition of the Newport News Times.

Based on these findings,

THE CITY OF NEWPORT RESOLVES AS FOLLOWS:

<u>Section 1</u>. The City Council of the City of Newport hereby names the Box Office at the Newport Performing Arts Center the Chris and Julia Carlson Box Office.

Section 2. This resolution is effective immediately upon adoption.
