A map showing the following: (a) The original and proposed lots. (b) Existing and proposed streets, alleys, and easements on or abutting the subject property. (c) Topographic lines at five (5) foot contour intervals stating the source of topographic information. (d) Approximate parcel size and parcel line dimensions. **1**4. A preliminary title report, lot book report, subdivision guarantee report, or any other report that establishes ownerships and easements, together with copies of easement documents.
- **□**5. Written letters from providers of public facilities (sewer, water, storm water, and streets) and utilities (electric and phone) stating the requirements for

the provision of public facilities and utilities to the proposed land division.
