

# Affordable Housing Partners

Category:

#### **NOMINATED BECAUSE:**

I am nominating the Affordable Housing Partners group because of their impact in the development of new affordable housing.

The Surfview Village Apartments, which opened in May 2020, were the product of years of public/private collaboration and partnership to: establish an affordable housing development incentive program in the City of Newport, attract an experienced high-density affordable housing developer, apply for \$11M in state grants and tax credits to fund the development, secure partnerships with service providers and tenant advocates to educate the public on application processes, assist prospective

renters with the lease up process and provide initial feedback to the development and property management team. No other community coalition, government entity or individual has had this big an impact on the inventory of affordable housing in our community.

# WHO'S INVOLVED? UPDATES FROM AFFORDABLE HOUSING PARTNERS' NOVEMBER 2020 MEETING:

**CSC**, **Dina Eldridge**: Working in partnership with CHANCE and Grace Winds to provide money for non-congregational shelter services. Project Turn Key, non-profit acquire motels that can be turned into shelter in the short term and supportive housing or permanent housing in the long term. Referral process goes through CHANCE for motels. Will present at the December meeting.

**NW Coastal Housing, Sheila Stiley:** Working on Project Turn Key identified a hotel in the Lincoln City area, two week turn around, the county will be involved, and need the city to be involved. Non congregate gathering space, need government buy-in, this is a short term, long term goal. Blackberry Apartments are going into permitting in January, breaking ground in April or May in Toledo.

**Habitat for Humanity, Lucinda Taylor:** Currently accepting applications for HH Housing, encouraging people to apply, deadline is December 1st.

**Helping Hands, Elizabeth Koraich:** Have permits in place for the east building. Gave a tour to Congressman Kurt Shrader.

**First Presebyterian, Don Gray:** Formed a new partnership with Safe Families for Children and will be providing a learning lab at the church.

Samaritan House, Lola Jones: Recently awarded funding to purchase wi-fi and computers for residents, in addition to PPE. Able to support the students to attend Apple Tree. Nonprofit Association of Oregon, Offering all their fundraising webinars for free through the end of the year.

LCSD - HELP Program, Katey Townsend: The school district is working on bringing students back to school based on grades in the hybrid setting. While there is still a continued need for students to have a place to do their virtual school, it would need to be the private groups, non-profits, businesses, parents, etc. that organize these informal groups. The SFFC and 1st Pres group is a great model for that!

#### MORE INFORMATION ON THEIR WORK:

Joseph Danna and his team at Panini do all they can to help the community. As just a few examples, they donate bread and pizza to Lincoln County Food Share, even when their business was shut down due to COVID protocols in 2020. After the wildfires, they donated sourdough rolls with cream cheese to Lincoln City emergency shelters for the evacuees and the volunteers. They make holidays brighter by donating bread to non-profits like Samaritan House. It's inspirational just to talk with Joseph about all the regular ways he helps the community break bread together, and all the future plans for continuing to help provide healthy, locally baked products for people in need. Specifically, providing free soil for our gardens last spring, their participation and collaboration on events like the one at Sam Case for Healthy Families of Lincoln County, their willingness to present to school groups and community members on waste management and sustainability, and the education they provide through social media on recycling and eco-friendly practices.

#### MORE DETAILS FROM THE NOMINEE:

For the last two years, Thompson's Sanitary has made a real effort in improving our business with an annual planning retreat, including many of our employees, in making goals and meeting monthly to achieve those initiatives. The first thing that came from that was setting up our core values:

All our decisions and initiatives are made with those in mind. Part of the process leading up to this was changing our logo. See this link for the explanation of change:

For the last four years our company has been committed to helping Newport Middle School and Sam Case schools in the process of becoming Oregon Green Schools where we worked with both cafeterias to create a lunch composting program diverting thousands of pounds from the landfill into nutrient-rich compost used in agricultural applications. Our company also invests both time and finances to the Green Team elective course at Newport Middle School through field trips and curriculum. Our hope is to continue to grow our support to all Newport schools as well as add additional opportunities for students to learn about how they can reduce their waste.

This last year also saw the first complete year of our newly launched free residential service app, which includes a Waste Wizard search engine (where customers can search the best method to dispose of their item), personalized service schedule, important service alerts and education, scheduling a bulky item pickup, or paying their bill. As the nomination included, we offered a free compost community event on Earth Day, April 25 where we back-hauled finished compost from Pacific Region Compost facility (where we haul raw Mixed Compostables from the curb and it's made into compost during a 75-day process). This event is in its fifth year and its purpose is to provide a truckload to each household for their own home gardens.





From March 19 through May 27, we ordered weekly takeout from locally-owned restaurants for our entire crew of 30. We ordered from Clearwater, Café Stephanie, Local Ocean, Sorella, Seadogs, Chalet, Cobblestone Pizza, Gyro Guys, Newport Brewing, Mo's Chowder, and La Maison in an effort to help them get through the initial shutdown due to COVID-19.



We also encourage our employees to volunteer in our community. Some of the organizations we serve in include four employees who are youth or high school coaches, Newport Booster Club, Rotary, Pacific Communities

This is very important to us because all of us at Thompson's Sanitary live and work in this community and we are invested in making it the best it can be.

Our company is also involved at the State level in our industry keeping up to date in current waste practices and serving in those organizations to further our State's goals of reducing waste. Beach clean-ups are also heavily supported by us, at the minimum covering the cost of disposal, for groups organized through SOLVE, Surfrider, Rotary, and Youth groups like Climate Coasties. Root Beer Floats, and drop-by 4th of July goodie bags. These events lifted the spirits of many community members during a difficult time.

The Newport Recreation Center and 60+ Activity Center were used during the Echo Mountain Fire Complex Incident as a community shelter for 230-250 evacuees and as housing for National Guard units from September 9-18, 2020. Recreation staff also shifted their mindset for community engagement by providing virtual programs during the 6-month closure. 60+ Center staff had to do a quick revision of how the center could operate while closed. Staff provided virtual lessons on how to use Zoom to connect family and friends. They also presented virtual presentations that included cooking shows, Making Plans, Photography, Camp Adair, Fall Prevention, Basic Estate Planning, the Conflict Cycle, Before the End of Life: Nuts and Bolts, How to use the online library and How to Cope during COVID.

#### 2020 COMMUNITY VISION AWARD NOMINEES

#### **NOMINATED BECAUSE:**

The Newport Trail Stewards (NEWTS) is a community group dedicated to building multi-use trails in Newport. An initiative of the mountain biking community in the greater Newport area, NEWTS has built and maintained trails in the forested lands near the Wilder community in South Beach, and is now partnering with the City of Newport to build a new set of trails on the city-owned property around the Big Creek Reservoir.

While the Big Creek project has been in the planning stages for about two years, 2020 was a watershed year for NEWTS, as it negotiated the final touches on a formal agreement with the city and achieved a number of other milestones. Despite the limitations of the pandemic, this year NEWTS has:

- Finalized an agreement with the City and carried out all administrative tasks necessary to begin volunteer trail-building
- Purchased insurance for trail workers
- Finalized a Big Creek trail map and a phased trail-building plan
- Flagged the routes of some trails on the property
- Received a grant of \$5,000 from the Oregon
   Coast Visitors Association as part of OCVA's Dirt
   Wave initiative, a plan to construct mountain
   biking trails to attract riding visitors to the Oregon
   coast
- Consulted with a professional trail builder
- Purchased hand tools
- Built two new trails at Wilder as demonstration projects: a machine-built flow trail called Social D and a hand-built trail called Upper Crazy Train. These trails were built with all-volunteer labor on designated trail building days

The trail system at Big Creek will be a critical outdoor recreation amenity for locals and visitors alike. It will include trails appropriate for walking and hiking as well as purpose-built mountain biking trails, and will likely be usable year-round.

1. Three years ago OCCFA was chosen as one of the Northwest Community Forest Coalition's pilot projects focused on all 50 Oregon Coast watersheds. This project continues to the present. OCCFA has continued to stay engaged in educating groups and municipalities in Lincoln County, and we and our partners have continued to complete an analysis of the Big Creek Watershed in Newport. Our partner Ecotrust completed the watershed mapping of the 50 coastal watersheds in 2020. Also, our partner Sustainable Northwest has recently completed Velma watershed modeling for the Big Creek Watershed.

#### 2020 COMMUNITY VISION AWARD NOMINEES

We expect to have a work meeting in early 2021 with the City of Newport to present this important modeling science that will help build a clear understanding of creating a forest management and ownership strategy.

- 2. Olalla Family Center's outdoor therapy Walden Project has continued to operate at OCCFA's Forest Hill in the era of Covid 19. They were able to provide therapy services for groups and individuals in a socially distanced manner. Also several private practice therapists have been able to book consistent days to provide Mental Health support for community members.
- 3. We welcomed a socially distanced Women's retreat at the OCCFA's Forest Hill and will offer the same organizers two retreat time slots this coming summer. Several County organizations also were able to book time for outdoor meetings at the Pavilion.
- 4. With Lincoln County School District as a partner, OCCFA added new signage to Newport's Forest Park. We are advocating for a Forest Management/Stewardship plan for Forest Park.
- 5. Lincoln County has initiated a conversation with OCCFA regarding a troubling contaminated property, and we have begun a multiple partnership planning process to remediate and restore this property and transition it into a community asset.

There is no denying that year 2020 was crazy. Just when you thought you had a handle on how to run your business during a pandemic covid cases would rise and back to take out only again. And then there were the fires...

At the start of the pandemic I thought to myself could this be the end on my 75-year old family business? It could have been.

We are still here and there are many reasons why.

Employees: In March of 2020 we had to lay off almost every single person. This was probably the most heart-breaking day of my life as a restaurant owner. In the darkest moments of the shelter in place when anxiety and uncertainty reined our employees always asked what can I do to help? A handful of staff stayed on to work day in and day out to get us through. They learned other jobs and never complained.

Family: My family banded together like never before. My mom came out of retirement to take over the

baking of cobblers, bread, cookies and brownies. In order to keep our heads above water my brother's 4 children, his wife, my son and my husband worked together to run the business. We took ourselves off the pay roll in order pay the staff who stayed on during the shut down.

Customers: We would not be here with out our amazing and generous customers. They supported us with take out orders either by calling in or stopping by. We received food delivery orders from customers who wanted us to take food to Newport Police and all of the fire departments in Lincoln County. This all helped.

Innovation: It is said that necessity if the mother of invention. In times like these businesses must become nimble and as creative as possible. We decided to take some of our homemade products on the road- store to door type concept. From March until the end of June we traveled all over Oregon, Idaho, Washington with clam chowder base, home baked bread, garlic cheese butter, mini cobblers and canned tuna. These sales literally saved the business. In each community that we visited we donated a portion of the proceeds to their local food banks. Mo's was founding was built giving back and that didn't change in 2020.

Relationships: In September Oregon was not only suffering from rising covid cases but wild fires were out of control. The coast historically has been spared by the damage of wild fires but not in 2020. Otis just north of Lincoln City burned. Hundreds of people were suddenly in need of shelter and food. Many residents of Otis ended up in Newport staying at the Rec. Center or area hotels. Mo's Newport partnered with Local Ocean and Clear Water Restaurants to prepare meals for 200 to 300 people. This brings me to another reason we are still here...collaboration. One of the silver linings of these unprecedented

times is the de-emphasis of competition and the emphasis on working together to make things better in the community that we share. Relationships with other restaurant owners were key to survival. We were able to help each through each and every struggle 2020 presented.

# **NOMINATED BECAUSE:**

In a year when arts organizations struggled to stay afloat in the face of the many challenges presented by the COVID pandemic, the Newport Symphony Orchestra found ways to engage the community, provide a welcome ray of musical sunshine during a dark time, and maintain its audience so fans will return in full force when conditions allow.

Like most arts organizations, the NSO was forced to cancel its spring and summer 2020 programming, including its beloved annual free Independence Day concert, and its 2020-21 season. COVID forced the closure of the Performing Arts Center and made mass audience gatherings unsafe, and it also became dangerous for musicians themselves to gather to create ensemble music. Rather than completely "closing up shop," the NSO immediately pivoted to a variety of kinds of creative programming.

First they provided short videos of NSO musicians making music at home, dubbed "NSO to Go!" One delightful video featured the orchestra's conductor, Adam Flatt, playing a violin-viola duet with his friend and neighbor Erik Peterson, concertmaster of the Denver Philharmonic. The two masked musicians recorded themselves playing Mozart at a safe distance outside. Seventeen other videos of this type followed, all shared

on the NSO's website and social media feeds.

Next the NSO refused to disappoint the community on Independence Day. Because the ensemble could not present their usual free concert that day, typically attended by about 1,000 people, they offered an encore performance of the 2017 concert broadcast on local radio stations. They also provided streamable video from the NSO website.

Patrons were able to purchase tickets to a Zoom performance of the Element String Quartet, made up of musicians from the orchestra, for a very special pre-recorded performance and a live discussion afterward. In addition, the NSO developed a short series (with more to come) called Musicians' Living Room, in which paying patrons could participate in an hour-long Zoom presentation by NSO musicians and the conductor.

Social media blew up with the partnership between the NSO and the Oregon Coast Aquarium in which two cellists played on location at the otter exhibit at the aquarium. The video was made available to the aquarium for pandemic-period fundraising.

Finally, the Friends of the NSO presented a Zoom wine-tasting event led by Adrienne Marler (Casa Bruno Winery), cohosted with JC Market, who offered wine selections at reduced prices. The event was free to attend, and attendees purchased wine to participate in the tasting. The NSO did

fundraising at the event and provided the contributions, over \$1,500, to the victims of the Otis Fires

In any year, the NSO is a community treasure. This year, their dedication to the community and their ingenuity are to be especially commended. I hope they will get your vote for a 2020 Community Vision Award.



Every detail was considered in the planning of this program. Reservations were easy, admission was by donation so all families could enjoy the shows, the movies chosen were broadly appealing, and all the logistics went smoothly. These movies allowed the community to gather in a safe way and to be

We have not had much press around our activities in the past year. We feel so rewarded by simply being able to help others, we don't feel we need to call attention to our charitable activities. We started our delivery service in March to address grocery shopping in the age of a pandemic. We travel from Yachats to Tillamook every Wednesday to deliver high-quality farm-raised food to our customers, no delivery fee or minimum order is required because we felt that would limit the ability of low-income shoppers to take part in the safety of our contact-free home deliveries. We expanded our services to be able to accept SNAP benefits as another way to include lower-income families.

We have worked extensively over the last 15 years to farm in ways that make the land around us better than it was when we started farming. We have planted orchards, installed water catchment for irrigation, and installed a sizable solar array on our barn, just to name a few items. By working to heal the land, we have created better living situations for our animals, which ultimately results in an abundant harvest. Because we have been blessed with such abundance we have the ability to work with local food pantries, churches, and restaurants to help feed those in need with healthy, nutrient-dense foods. Farming is intensely difficult work, but it is such a rewarding job; I can't think of anything we would rather do.

The team is led and staffed by Jessica Palma, Susan Traschel and Sara Herd of Lincoln County Public Health, who along with Casey Miller, County PIO, and Jenny Demaris and Samantha Buckley of County Emergency Services, provide the infrastructure for the public face of the pandemic response.

Meeting twice weekly since the beginning, the group includes but is not limited to representatives from County Public Health and County Policy Leadership, Samaritan Health Services (both for North Lincoln Hospital and Pacific Communities Hospital), the Lincoln County School District, local representatives of State Social Services Agencies including Department of Human Services/ Self Sufficiency Program, local nonprofits including My Safe Place, County Safety Agencies (law enforcement and 911), cities and the Hatfield Marine Science Center.

Together these groups and their representatives have insured information is made available through multiple media and messaging mechanisms, culturally and language specific when possible. They have collaborated in sharing information, resources and tools to address everything from case counts and locations, to outbreaks; from state and local efforts at preventing spread of COVID to current efforts to get vaccine shots in arms countrywide.

### **NOMINATED BECAUSE:**

Lincoln County School District went above and beyond to provide meals for students over the summer. They found funding to provide breakfast, lunch, and dinner to students at a time when many families were financially impacted by COVID-19. For families unable to make it to the schools to pick up their meals each day, LCSD packaged and delivered boxes with enough meals for the week. This was no

small effort, requiring outreach to make sure all families were aware of this opportunity, designing nutritious menus with meals that are easy to prepare at home, ordering supplies, preparing hot lunches, packaging breakfast and dinner items for daily pick up and boxes for weekly deliveries, scheduling pickup sites and drivers and buses for deliveries, and making sure it was all done safely in accordance with appropriate food handling procedures. LCSD helped make sure their students had the nutritious meals they needed to help them stay healthy during a national health crisis. Kudos to everyone involved.

# MORE INFORMATION FROM THE NOMINEE:

Lincoln County School District recognized quickly that the COVID-19 shutdown would heavily impact our community as our local families are dependent on their incomes from businesses that had been closed. LCSD and our partners at Sodexo and First Student quickly initiated emergency planning. Long hours and a good working relationship with the Oregon Department of Education (ODE) Child Nutrition Program ensured our kids would see no lapse in meal service. We had 3 goals, that no kid in Lincoln County went without a meal, that we could still provide jobs for our partners and that we would do it as safely as possible.

On Friday March 13th a plan was created and approved by the superintendent and ODE to begin our feeding program on Monday March 16th. We were one of the first schools to move forward. That weekend was spent organizing staff, gathering volunteers and meal planning, fully prepared to serve all 6,000 plus kids living in Lincoln County if needed.

Food Service staff met on Sunday to begin preparations and Meals on the Bus was born. And so, each day, rain or shine, for the past 10, almost 11 months, the First Student school buses pull up to the school kitchens and Sodexo Kitchen and Custodial staff load thousands of meals for distribution, serving 3 meals a day, 7 days a week.

The program has seen a few adjustments over time as the pandemic restrictions change but the goals remain the same. When students come back to school in February, staff will have served over 1 million meals to the youth of Lincoln County and have helped keep over 150 food service and bus employees working. This was not done alone. Classified staff, volunteers, and community partners all stepped up to support this effort. We had hundreds of coolers donated in the early days and even a refrigerated trailer from Newport Bike. They saved us. Not only do we need to feed kids but while doing so, we needed to continue to follow all the local, state, and federal safety rules.

We had many local companies donate items and even monetary donations. Mo's turned thousands of gallons of clam chowder into individual serving packages ensuring that our program continued when our suppliers struggled to meet our demand. Local grocery stores donated bags and extra produce, and Lincoln County's own tooth fairy, Kelli Thompson, donated toothbrushes for each child with support of the community. Our longtime partner, Altrusa, stepped up without hesitation to support meal packaging relieving some of the pressure from our exhausted staff whom have seen very few days off during this time.

Our own Facilities and Maintenance team, run by Director Rich Belloni, has been invaluable during

these times, moving equipment from one end of the county to another and making sure we have everything we need to succeed.

When the wildfires hit in September, Meals on the Bus continued. Our First Student staff took buses as far as they could, right up to the evacuation lines and helped deliver Red Cross Meals that Sodexo staff prepared on top of the meals already going out for the kids. Lincoln County utilized all funding sources available to the fullest extent, including our Fresh Fruits and Vegetables grant that allowed for extra unique produce to be served and Farm to School grants which allow purchases from local and state vendors such as Bagel Sphere, a small bakery out of Eugene, who produced school formulated fresh bagels and breakfast sandwiches, and Rock Face Creamery who provided cheese curds.

Sodexo General Manager, Patty Graves, has already been recognized nationally, receiving the Schools Exceptional Heroes Award for her part in Meals on the Bus, and Lincoln County School District has been looked at by many school districts as a role model to follow in the state. Meals on The Bus has proven above all that the partnerships of this community will succeed in anything they set out for, no matter the roadblocks or struggles. A special thanks to the front-line team, your heart and dedication unites us all.

The Newport Booster Club has been active in Newport since the 1950's providing thousands of dollars to support NHS student athletes, athletics and extracurriculars. This year in response to COVID-19 economic effects, with many families being out of work and experiencing food insecurity, they raised \$58,860 in three months which the amount in entirety translated to \$50 JC Market gift cards being given to Yaguina View, Sam Case, Newport Middle, and Newport High Schools for them to identify and distribute to the most needy families to buy groceries. And most recently during the Holiday season, something they've done annually for several years, asked folks to donate to the H.E.L.P. program and collected \$12,000 to support Newport High School homeless students with gift cards to Fred Meyer to buy clothing, personal items, and groceries. All of this was done solely to support Newport's youth and their families.

Newport Boosters support student-athletes with a fund that provides support for families with multiple students who must pay to participate in sports or for multiple sport athletes which the family cannot afford but are willing to work off part or all the fees. The Boosters have paid all or part of the "pay to play" upfront cost of about 187 fee waivers annually for

athletes in high school and middle school sports. No student-athlete wishing to participate in sports will be prohibited because of the cost. We spearheaded the turf projects and partnered with the school district to get more kids participating in healthy activities outside (more playable field space and year-round) in organized and non-organized sports, PE classes, etc. Per the US Department of Education, the percentage of students who graduate dramatically increases when they are involved in sports. "Students who participate in extra-curricular activities are three times more likely to have a GPA of 3.0 or higher." Extracurricular activities like sports increase a student's connection to the school, raise self-esteem, and have positive social effects.

Please keep in mind that due to COVID-19 this year fund-raising activities and meetings were all done virtually. Even our Fall Banquet, which is one of our most successful fund-raisers, was done virtually and was an accomplishment that shows the talent of our members, <a href="https://youtu.be/ZwhW8\_I7ANE">https://youtu.be/ZwhW8\_I7ANE</a>. Other events like the Boosters Spring Auction and Booster Bash golf tournament had to be canceled. The Newport Marathon, a community event owned and operated by The Newport Boosters Club, brings attention to our area from all over the country and the world. Many local businesses and organizations benefit from their participation during the event. This also had to be canceled.

Our accomplishments would take several pages. A few are: The Newport High School Boosters provides most of the funds for Newport Middle School athletics and at our 2019 Fall Banquet, outside of our normal fundraising, our attendees raised their paddle and invested \$12,600 for 63 Chromebooks for Middle School students. Newport High, Frank Wade Baseball complex, Yaquina View Softball complex, West campus practice field, and Newport High Gym have all benefitted from Booster investment and work programs. The Sports complex at Newport Middle, with snack bar and restrooms, is the most recent and yet to be completed project.

Our primary focus is high school athletics, and we are community members, so we can pivot to address the needs of our community under some dire circumstances like we've had in 2020 and still maintain our primary focus. This award would be a wonderful acknowledgment for our members for a job well done.

Alex has also been working with local businesses to provide fresh produce to families during the pandemic and using local resources for these to be provided in food boxes.

Alex Llumiquinga and Alex Guevara helped so many people in the Latino/Indigenous community that were, and are affected by the effects of Covid-19, completing medical applications for them due to language barriers and lack of knowledge of the system.

It was a team effort throughout the response, which has consumed most of our lives and in spite of COVID we still have a commitment to the community that extends beyond simply responding, like the conference.

# **Community Health**

Ongoing normative services essential in light of COVID-

- \* Harm reduction services have increased in need as data has shown the increase of overdose during COVID. As a result, the department continues to offer services.
- \* CARE domestic violence and sexual assault program also has seen significant increase in need to safely shelter folks and those services have remained consistent throughout the pandemic
- \* Non-emergency medical transportation services are available for emergent critical health care needs

# **Emergency Response team by branch:**

- \* Call out team: responsible for calling all enrolled tribal elders (approximately 1000) on a regular and ongoing basis. Initially we called every elder every day, now we call each elder monthly unless they are vulnerable in which case we call more often.
- \* Ground Team: These folks locate and procure those hard to access supplies, run the distribution center and pack up and deliver the requested elder needs. Offer distribution events to provide masks to the community

- \* Call in line: helps navigate and connected the general membership with available COVID resources.
- \* Community connectedness project: This team is working on assembling videos of positivity (reading to kids, cooking, traditional dance, drumming...) and is really a community effort where folks videotape messaging and the team edits and posts so we can see each other and provide hope.
- \* Case Investigation and contact trace: We have a team trained to do case investigation when requested by the county and a team that does the contact trace for all that test positive at the clinic.
- \* Organize, schedule and run weekly vaccine clinics.

### **Partnerships:**

In addition to these core projects, we are also collaborating with other departments to assist with large projects.

- \* Care packages for all elders from community health and the elder's program, went out early in the pandemic. All elder received a care package with hand sanitizer, gloves, masks, information, snacks, puzzles, traditional/ceremonial supplies.
- \* We worked with USDA in the beginning to open the service to the community and help to get food to those in need through this partnership.

### 2020 COMMUNITY VISION AWARD NOMINEES

- \* We run pharmacy deliveries daily to tribal members to ensure they receive the medication they need. These are all new and different roles for all of us
- \* We distributed phones and phone cards to ensure folks have access to information and can connect with medical provider.
- \* We supply support to help people isolate when a household member test positive through a partnership with local hotels to house those in the family that have not tested positive.
- \* We collaborated with other departments to find funding and contract the building of the comfort station, which will serve as a sanitation station for those without access to bathroom, shower and laundry facilities.
- \* We partnered with the city and many departments to respond to the fires at the end of summer, which included building a shelter, manning the shelter, providing access to shower facilities and feeding evacuees.

This collaborative group sets a positive example for other coastal neighborhoods and communities who want to prepare for natural disasters.

### MORE INFORMATION FROM THE NOMINEE:

The South Beach Community Disaster Cache Planning Group is a local volunteer community committee that oversees the planning and development of two South Beach tsunami assembly areas-Save Haven Hill and one at Oregon Coast Community College. The caches at these sites are being filled with water, food, medical, sanitation and shelter supplies intended to support those that work, live and play in the South Beach community for up to two days after the event. All supplies have been donated to this community effort. The planning group is made up of representatives from state and federal agencies, Oregon State Parks, the Port of Newport, nonprofits, and businesses located in South Beach and the City of Newport and local community members.

I am consistently blown away by his generosity and kindness, and he spends an abundant amount of his free time also helping our vulnerable populations that are not involved in the court system. Without a doubt he is one of the strongest advocates for the people in our community that need it the most, from the homeless population to drug and alcohol addicts. This includes him comforting upset strangers in the courthouse hallway, offering a friendly face to people outside of work hours, providing his support to people hours away from Newport that have relapsed and are scared, feeding a homeless man for weeks when the man refused to turn to others for help, and even sitting with a person seen laying on a sidewalk to talk and see if they are okay. His positive impact on our community is endless, and even after a past lay-off he chose to remain in the Lincoln County area to help provide much needed mental health and addition services.

Mary explained that her caregiver purchased most everything she needed but came up short with her remaining food stamps and was unable to get any (pre-cooked) turkey or ham to complete the meal. In the process of chatting with Mary about how we may help, she let out a sigh and said, "It sure would be nice if I had one of those walkers with a seat," as if she was daydreaming. "It would give me so much freedom and the ability to get out of the house once in a while." She shared that due to issues with her legs, she can only stand for about 2 minutes before she has to sit down again. We knew the immediate action we could take was to purchase portions of cooked turkey from a local store deli and deliver to her in time to finish putting together the meal for her and her disabled son. Then, a light bulb went off as we recalled someone telling us recently that they had a walker to give away. We inquired, and the walker was still available! (Thank you, donor!) Today we delivered the turkey meat in time for the mother & son visit AND surprised Mary with a walker (a very nice one with all the bells and whistles). Needless to say, she was overwhelmed with joy and excitement! What a great Thanksgiving moment! Wishing you all many meaningful Thanksgiving moments!

She serves on city council and also works for OSU extension. She participated in all of the COVID listening sessions with our latino & indigenous community members. She is part of the CEIC and Juntos en Colaboracion and is a leader in both groups helping us move forward. The amount of progress made just in this year towards equity and inclusion of all of our latino/indigenous neighbors was in no small part because of Beatriz's efforts. For the first time ever, it feels like we're really making progress finally! Many people were part of this, but Beatriz's leadership and connections is really making a difference.

### **ALSO NOMINATED BECAUSE:**

Beatriz is a true inspiration who is giving of her time and energy, and always looking out for all members of our community. By putting extra effort into supporting Latinx and Mam populations through the COVID-19 crisis, Beatriz helped facilitate several tri-lingual community listening sessions that enabled so many residents to get access to information and assistance that would not have been possible otherwise.

Beatriz Botello chose to recognize her work with LISTOS as a Government Organization instead of being recognized as an Outstanding Individual:

I'd like to nominate Ginger Gouveia for her work in collaboration with Pastor Angel Torres-Moreno of the First Baptist Church in Newport, in organizing a community-based network. Acompañar, of volunteers working with Food Share to provide bi-weekly delivery of food boxes as well as small monthly stipends to the families of immigrant workers in local restaurants, hotels, and other tourist-related local businesses who have lost their jobs due to the pandemic and have no access to government resources for help. Ginger reports that since last April they

have raised enough funds to distribute over \$74,000, including cash and food plus items like detergent, toothpaste, soap, rice, and beans to these families.

Acompañar founder. International traveler to Palestine. Activist for immigrant rights in Oregon, and at the state prisons. The state prison is at Sheridan.

Also an artist! A few years at VAC, she had a photography exhibit titled "Children of the World."

### FROM THE NOMINEE:

Ginger wants to recognize both the committed volunteers of Acompañar and the generous community support along with the Individual nomination she received.

Acompañar had its beginnings in the summer of 2019 with a volunteer effort to provide our Guatemalan asylum seekers with no-cost transport to their monthly meetings at ICE office in Eugene. Prior to that time individuals were paying more than \$200

each month for someone to drive them since they could not legally drive themselves and were required to make monthly check-ins.

Our immigrant community is essential to our tourism and fishing industry. When Covid-19 arrived it impacted their incomes and a fundraiser was established to provide these families with at least some cash and food. Because of their non-resident status they had no access to government resources. What began as assistance to nine families soon grew. Today about 70 families are served each month. When they regain employment they let us know that they no longer need help. But, some have been laid off two or three times.

With the help of <u>Food Share</u> a biweekly distribution of food, including ethnic foods, is provided to the families. Donations from our generous community members plus a few small grants have provided the necessary funds to continue this work during the devastating impacts from COVID-19.

With eight committed volunteers, and especially Pastor Angel Torres-Moreno of the First Baptist Church in Newport, our work continues. And there are no overhead costs. All of the collected funds go directly to the families.

Donations are still needed to provide help for a few more months with the hope that our tourism and fishing industries return to normal soon.

### **ALSO NOMINATED BECAUSE:**

A collaborative team came together called Juntos en Colaboración to work on addressing the needs related to not only the COVID-19 pandemic/wildfires but looking at long term systems changes and overall improvements of services for Latino/x and Indigenous communities in Lincoln County.

This collaborative group has hosted <u>community</u> <u>listening sessions and have leadership panelists like</u> <u>the health department director, or the Samaritan</u> <u>Health director.</u> Community members of the Latino/x and Indigenous communities can ask questions to the panelists about concerns or needs they have. They also have interpreters to help during those meetings. This has led to some immediate changes.

This group developed a <u>youtube channel</u> where they got community members to help with the making of videos related to COVID-19. Something like learning how to properly wear a face mask was needed to help inform the community how to stay safe. This was a huge need for the Latino/x and Indigenous communities.

They also worked together to put together a <u>virtual</u> <u>cultural fest</u>. While these efforts were led by the Olalla Center, the group helped with anything they could, such as participating in the videos, translations, or monitoring chats during the live feed.

Blair Bobier of Legal Aid Services, Lincoln County Office, stepped up to organize a group to discuss homelessness issues. The advent of COVID-19 caused the meetings to cease temporarily, but the expectation is that as soon as the players have less on their plates, this group will be back up and running to address this critically important issue.

organized & been a co-trainer of volunteer mediators for over ten years--a 32 hour training program necessary to qualify those who complete the training as community mediators. He worked with the state judges in Lincoln county (Lincoln county courts) to involve local mediators in mediating FEDs and small claims courts, providing the parties with a way to settle their dispute with the assistance of a mediator in ways that a judge can't provide.

LCDR has mediated workplace conflicts, family conflicts, et al. and facilitated decision processes for HOA and condo associations/boards for many years, in addition to offering short classes (1-2 hours) in basic conflict mediation skills. Members of LCDR have participated in a restorative justice program for minors while that program was funded. In the past, LCDR provided support for training of school children as playground mediators (during school hours), providing volunteer mediators to coach and/or support the child mediators. LCDR did and does all of that for free. There is minimal funding support for county community dispute resolution. While volunteer mediators have come and gone, Patrick McGovern has remained & when needed assuming leadership of the organization. He believes that peaceful resolution of conflicts is possible and he walks his talk to make his belief reality both in Newport and all of Lincoln county.
