1. Call to Order
 - a. The meeting was called to order by Chair Geltner at 8:40 AM.
2. Approval of Minutes
 - a. The April 5, 2018 minutes were approved.
3. Discussion/action items
 - a. A discussion ensued regarding the Committee's need for the City to give the Committee direction on where to go. The Committee asked for the Glick Study relating to South Beach and Nye Beach and the Meyer Reid report for the next meeting. The Committee discussed going to City Council for direction. They also discussed connecting with the 2040 study.
 - b. The Committee talked about how often to replace the Wayfinding maps. It was decided that they should be replaced every three years or as needed.
